I, the undersigned, Pierre Fréreau, Assistant Secretary-General and General Counsel of Concordia University residing and domiciled for the purpose of the present affidavit at 1455 de Maisonneuve Blvd. W, Montreal, Quebec, H3G 1M8, after having been duly sworn, declare as follows:


1. I am the person responsible for access to documents for Concordia University;
2. With respect to file 06 15 32, I have transmitted to Dr. Bernans all documentation relating to his room booking for an event to be held on September 11, 2006, as requested by him on July 26, 2006;
3. Such documentation solely consisted of the following:

- E-mail sent from booking@alcor.concordia.ca to dbernans@sdf.lonestar.org on July 20, 2006, entitled "Security has APPROVED your event";
 - E-mail sent from booking@alcor.concordia.ca to dbernans@sdf.lonestar.org on July 24, 2006, entitled "Security has DECLINED your event";
 - E-mail sent from dbernans@sdf.lonestar.org to booking@alcor.concordia.ca on July 24, 2006, entitled "Re: Security has APPROVED/DECLINED your event";
 - E-mail sent from Veronique Borja (booking@alcor.concordia.ca) to dbernans@sdf.lonestar.org on July 25, 2006, entitled "Re: Security has APPROVED/DECLINED your event".
4. This constitutes all documentation in the University's possession within the ambit of Dr. Bernans' request dated July 26, 2006;
 5. No portions of these documents were modified by the University;
 6. With respect to file 06 19 01, there exists no list of persons who have participated in the bodies to which Dr. Bernans refers in his letter of October 28, 2006 (or any similar body);
 7. Concordia University has completed all required research to attempt to ascertain the existence of such documents;
 8. As such, Concordia University is in possession of no documents which could respond to his request;
 9. The individuals mentioned by the Plaintiff is an ad hoc advisory group that is convened from time to time by the Vice-President, Services in order to discuss issues of his choosing, therefore there is no agenda or minutes.
 10. All the facts stated in the present affidavit are true.
